CAMINO SCHOLARS

AT ROLLING HILLS APARTMENTS

Working to increase math and literacy with People's Self-Help Housing.

Camino Scholars is a site-based learning program and the first site of its kind in Templeton that supports educational growth and enrichment for low-income families. Consisting of cohorts with 20:1 student mentor-educator ratio, the mentor-educator works with the student, the family and the school to bridge the gap between the three.

MEET ALI

Ali is in 1st grade and because of the pandemic had not been in a classroom before. Her parents tried, but juggling multiple work schedules and Ali at home in virtual kindergarten was too much and they were overwhelmed. Ali came to the program below grade level in math and reading. Camino Scholars provided daily learning opportunities for her, helping with homework, and ultimately bringing her to grade level.

COVID COMMUNITY RESPONSE PROJECT

Keeping people housed with financial and social support thru El Camino Homeless Organization.

The COVID Community Response Project directly impacted people in our community affected by the pandemic. Together we helped families pay bills and rent, purchase groceries, find new job opportunities, and worked to keep them on track – and in their homes. The goal of the COVID Community Response Project was to keep families housed.

MEET JEFF

Jeff's wife contracted COVID while pregnant and had to leave work indefinitely. After a series of complications, she delivered months earlier than expected Thankfully, their baby is healthy and thriving, but those first few months were spent in NICU. Jeff got behind on bills and struggled to catch up. Case managers provided assistance with utility bills to keep Jeff's family housed and moving forward.

BOYS & GIRLS CLUB

Expansion of the Boys and Girls Club in rural Shandon and Creston and opening of a state-of-the-art new clubhouse in Paso Robles

The club provides character and leadership development, education and career development, the arts, health and life skills, sports, fitness, and recreation programming.

In Shandon and Creston, the Club fills a much needed gap by establishing onsite programs, the only after school program at both schools.

MEET DANIEL

Daniel comes from a single parent household who loves being in kindergarten. But his mother's employer recently told her she could no longer leave in the middle of the day to pick him up from school. She had a difficult choice to make; thankfully, she only had to find a temporary solution because the Boys and Girls Club recently opened in Creston. Now that it is open, Daniel has a safe place to go after school to get help on homework, play with friends and learn life skills.


